SUBJECT: 2022 BUDGET SCHEDULE	

RECOMMENDATION

THAT with respect to Report No. 2021-25 (Corporate Services Division), we, The District of Thunder Bay Social Services Administration Board, approve the 2022 Budget Schedule as presented.

REPORT SUMMARY

To provide the proposed 2022 Budget Schedule to The District of Thunder Bay Social Services Administration Board (TBDSSAB or the Board) for approval.

BACKGROUND

Administration prepares and presents annual operating and capital budgets to the Board for review and approval. To support this effort, the Board approves a Budget Schedule which identifies when the budget will be presented to the Board as well as certain administrative milestones during the budget process.

COMMENTS

In accordance with the Budget Policy #CS-02:83, the Budget Schedule is to be presented to the Board no later than June in each year. Table 1 below, presents the 2022 Budget Schedule as proposed by Administration.

The proposed Budget will be presented to the Board at the November 2021 Board meeting for review and deliberation. Administration will incorporate any feedback from the Board, as well as any additional information provided by provincial Ministries, and resubmit the Budget for approval at the December 2021 Board meeting.

However, these proposed timelines, in particular the budget presentation to the Board and the related presentation for final approval, may be subject to change, depending on Provincial funding announcements, the potential impact of the COVID-19 pandemic, and timelines related to the future years' funding allocations.

Administration will provide further information regarding the Budget Schedule to the Board if/as required.
