




2. Revenue History and Trends Revenues Sources





1. Tangible Capital Assets Housing Portfolio - Decade of Construction



2024 Context and Impacts

Program Area	2024 Impacts
Social Assistance (Ontario Works)	 Program Delivery Funding to remain at 2018 actual levels
Child Care and Early Years	 CWELCC implementation Expected New Provincial Funding formula for 2024 budget (Revised funding formula combining funding streams) September 27, 2023 – Ministry confirmed funding to remain consistent with 2023 until 4th quarter, Admin Funding unknown
Community Housing and Homelessness Prevention Program	 Homelessness Prevention Program Funding (2nd year of \$16M for 3 years) first TBDSSAB budget that will reflect the full increase Canada-Ontario Community Housing Initiative (COCHI) funding is less than expected and amount unknown after March 31, 2025
Direct - Owned Housing Operations	 Increase in Operating costs Rent revenue shortfalls due to higher than industry vacancies
